Since its operationalization at CMP.1 in Montreal Joint Implementation has contributed to the implementation of mitigation action under the Kyoto Protocol, supporting parties to leverage private finance and project development experience to support the delivery of action of climate change. JI has also served to facilitate cooperation between Parties in the development and support of mitigation action. In adopting the Paris Agreement Parties recognized that the operation of JI can inform the design of new cooperative approaches. This event will provide Parties and other stakeholders with an overview of the lessons learned through this experience which can serve to inform the development of new national policies and international cooperative approaches in service of the Paris Agreement.

ICROA Roundtable

The entry into force of the Paris Agreement represents a unique opportunity for voluntary action. For the first time, both developed and developing nations have pledged to reduce their greenhouse gas emissions. However, the scale of emission reductions pledged is insufficient to restrict the increase in the global average temperature to well below 2°C above pre-industrial levels – the primary objective of the Agreement.
