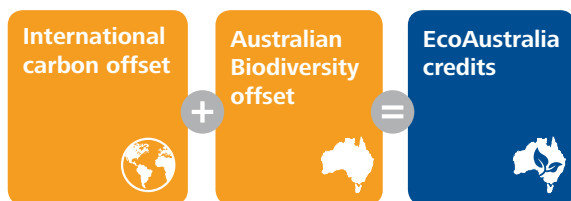

The best of both worlds

EcoAustralia credits guarantee the protection of Australia's remaining high quality native vegetation and are backed by accredited carbon credits from international projects. Our product is a "stapled" offset - a high quality international carbon credit with a national biodiversity benefit. Each credit represents one tonne of avoided carbon dioxide emissions from international projects, plus an Australian Biodiversity Unit, representing permanent protection of Australian native habitat.

Carbon emission reductions

We supply carbon credits issued under various standards including:

- Verified Carbon Standard (VCS)
- Gold Standard

Both standards are endorsed by ICROA, a global non-profit industry body promoting best practice in voluntary carbon management and offsetting. They are also the only voluntary carbon offset standards currently compliant with the Australian Government's NCOS standard. Credits from projects developed according to VCS and Gold Standard provide environmental, social and economic impacts for affected communities, contributing to the Sustainable Development Goals.

All credits are sourced from certified renewable energy projects.

Australian Biodiversity Unit

Australian Biodiversity Units (ABU) represent government-accredited habitat protection, with a covenant being placed on the land title to ensure the vegetation is managed for conservation in perpetuity, and the credits retired on the Victorian Government's Native Vegetation Credit Register. Each ABU represents approximately 1.5 square metres of permanently protected land.

Vegetation types may include forests, grasslands, mallees, saltmarshes, scrubs, shrublands, wetlands, and woodlands.
